GOING TO HONGKONG ~~THAILAND~~ NEXT DAY. BECAUSE SHE IS THE REASON WHY IM GOING IN THAILAND.  
AND I BOOKED A TRIP GOING TO HONGKONG UNTIL (OCTOBER 18-20) BUT FIRST I ASKED MY FRIENDS AND  
FAMILY IF ANYONE WANTS SOMETHING IN THAILAND, LIKE MENTHOL INHALER, BALM FOR THE PAIN JOINTS,  
LINIMENT, FACE POWDER AND LOTION (TREND IN THAILAND) AND MY FRIEND MESSAGE ME HER NAME  
IS "ANA SOPHIA" SHE TELL ME THAT, "ME, CAN YOU BUY ME MENTHOL INHALER? I REPLIED, HOW MANY? SHE SAID 2.  
AND SHE SAID IF I CAN BRING THE LUGGAGE IN HONGKONG. AFTER THAT I SAID WHAT IS IN THE LUGGAGE?  
AND SHE SAID GOLD NECKLACE ICED-OUT AND SOME GOODS. AND OF COURSE AS A FRIEND I SAID YES TO HER AND  
SHE OFFER ME TO EXTEND MY TRIP IN HONGKONG SO IM STILL IN HONG KONG UNTIL 24 OCTOBER AND AT MIDNIGHT  
BACK TO PHILIPPINES. IM GOING TO HONG KONG BECAUSE I WANT TO TRY TRAVEL ALONE, EAT ALONE, BUY STUFFS  
ALONE GO TO DISNEYLAND AGAIN AFTER 9 YEARS. AND ALSO I WANT TO TAKE A CHANCE TO BUY SOMETHING LIKE PERFUME  
BECAUSE ITS CHEAP THERE UNLIKE IN THE PHILIPPINES SO I CAN SELL IN MY FRIENDS. ALSO ME AND MY AUNT PLANNING  
BUY A 20 CLOTHES FOR OUR PROMOTIONAL OPENING IN OUR SMALL BUSINESS BECAUSE THE CHRISTMAS IS NEAR SO WE NEED  
SOME GIVEAWAY LIKE FIRST 20 KIDS GOT HAIRCUT (1) FREE CLOTHES AND KEYCHAIN FROM HONGKONG. THATS IS OUR  
PLAN WITH MY AUNT.

AND SO, MY FRIEND "ANA SOPHIA" SHE TOLD ME THAT I NEED TO BE EARLY AT AIRPORT IN THAILAND.  
AND AFTER A MINUTES, IM THERE AT THE AIRPORT BKK, AND SHE TOLD ME TO GO IN ENTRANCE 2 SO I CAN PICK-UP  
THE LUGGAGE AND AFTER A MINUTES SOMEONE AT MY FRONT ASK IF I AM MA. CRISTINA FERNANDEZ AND  
I SAID YES DAM. HE'S A INDIAN GUY HE GIVE ME 2 LUGGAGE, AND IM SHOCKED BECAUSE WHY I HAVE 2 AND  
I CALL MY MY FRIEND TELLING ME IT'S OKAY, IT'S SAFE AND NO NEED TO WORRY. I SAID OPEN FIRST BECAUSE I

I CAN'T THINK PROPERLY AND I'M NERVOUS. AND AFTER THAT MY TRIP WAS SO SMOOTH UNTIL ~~THE~~ WAITING THE BAGGAGE. AND AFTER 15 MINS APPROX. GOT THE BAGGAGE AND GOING TO OUTSIDE BUT THE CUSTOMS AIRPORT STOP ME AND HE SAID HE WANTS TO X-RAY MY BAGGAGE AND AFTER THAT. HE ASKED ME IF THE BAGGAGE IS MINE AT FIRST I SAID "YES" BECAUSE I REALLY DON'T KNOW WHAT IS HAPPENING. HEAL MY HEART FATHER JOHN AND PRAY MY BRAIN NOT TO OVERTHINK EVERYTHING AND NOT TO TAKE REVENGE TO MY CALLED FRIEND, I'M ALWAYS PRAY THAT I CAN ~~BE~~ GO HOME AND BE WITH MY FAMILY. I READ SOME NOTES IN BOOK EARLIER AND SAYS, "ONE OF THE MOST LASTING PLEASURES YOU CAN EXPERIENCE IS THE FEELING THAT COMES OVER YOU WHEN YOU GENUINELY FORGIVE AN ENEMY WHETHER HE KNOWS IT OR NOT".

FATHER JOHN, PLEASE VISIT US HERE ~~IN~~ IN TAILAM  
PLEASE HELP US TO GO HOME. OUR FELLOW FILIPINA TELLS ABOUT YOU AND FATHER JOHN  
PLEASE PRAY US AND HEAL MY ANGER, SAD HEART.. I HOPE I CAN TELL YOU EVERYTHING  
IN PERSONAL, I'M SO STRESS THAT I CANNOT TAKE THIS ANYMORE BECAUSE I DIDN'T  
DESERVE THIS. I'M INNOCENT, WE ARE INNOCENT.
