I'm a full time college student studying Bachelor of Science of Nursing at Our Lady of Fatima University Lagro Quezon City. I heard of so many stories at you here in Tai Lam Women Center from my fellow Filipinas that you help them with there case and also visited them personally. As a 22 years old who wants to seek help from you and now I am writing to share my story and hopefully you help me and you can also visit me here.

We just finished our Prelim at school and our school gave us 2 weeks break before continuing our midterm and taking exam. I was so excited because finally I got the chance to travel and decided to go to Thailand to unwind and to have fun alone. I used my saving from my week allowance because I loved to travel. Oct 10, 2025 I went to Thailand into Bangkok and stayed there for 3 days I had so much fun and I went to their temple and got to wear their traditional dress. Also I went to Phuket for water activities and did a day tour and meet people from other countries. I stayed there for 2 days because I have to fly back to Manila, PH on Oct 15, 2025, but then on my last day in Thailand I received a message from a classmate in my University her name Rexene Cortez she said "Oh, you're in Thailand!" I think she knew because of my post on social media. And I said "yes" I am here, why? "Do you wanna extend your vacation? its great since we still have 1 week left before our class starts" she said and I said "Yes" again and she told not to worry about the ticket and my hotel but this is going to Hong Kong and I was so flattered because its a "free travel" for me. "But I want you to take this luggage of mine to Hongkong it has some jewelry and chocolates that I am giving to my family in HK" she added. I was so naived that I didn't even questioned her about the luggage because I was so confident and comfortable that there nothing wrong helping her with that. On the day of my flight she called me again and she said "someone will give you the luggage because im sick" so I didn't questioned her again so waited to that someone for 5 minutes and an Indian guy gave me the luggage but he confirmed first if it was me the one that Rexene Cortez telling him about. And in that moment I asked them who will going to received the luggage and Rexene said that shes going to message me once I landed to HK. so I checked in my luggage and the luggage they gave me. It went well. I left ~~The~~ Subharnvami Airpo Thailand Oct 18, 2025 at 2:00am and I landed in HK Airport at 6:00am local time. I have passed the immigration and went straight to the baggage claim. I text Rexene asking for her family and she said that they are outside waiting. But soon as I got the luggage getting closer to the exit. suddenly undercover

But then when they opened it because of my surprise that there's no chocolate or jewelry that Rexene told me inside the bag was some Thai chips and a blanket and inside the blanket police took out 20 big packs of cannabis as the police told me I have no idea at all and I don't know cannabis or ^{seen} any drugs in real life. Police total of 10 kg of cannabis they handcuffed me and seized all my belongings and detained me I told them what really happened but it seems like they're not buying it. I cried because of fear and my family don't know anything, I didn't get the chance to contact them and to tell them I was captured. They detained me for 2 days and went to court Oct 20, 2025, while waiting for my hearing I met two Filipina Aquea Monique Villarena and Ma Cristina Delos Santos Fernandez both 26 and 27. We started talking about each case and we figure out we're all the same, same day flight, time, same Indian guy, same airport Thailand and Hongkong and most of all same person were pointing out Rexene Cortez they told me that ^{the person} they recruited ~~them~~ ^{by} ~~them~~ - named Ana Sophia Daymit Macapagal are friends with Rexene Cortez we found out that they used us they made us traffic illegal drugs we're all devastated because we have been victimized of this type of crime that we didn't even know and we're not involved because if we knew that this is illegal why would we bring such a heavy crime into a country that I never been to. I was just hook up by the free travel that she offered me and trusted her because I know her and we go to same university and I didn't think she would do this to me I was being good and kind to her as she offered me this. We just want justice and clear our names from the crime that we all also victim.

I am reaching to Fr. John hoping you could help us and visit us here in Tai Lam it's been 10 days since it happened. Please pray me to God and give us strength and faith, we know one day everything will be okay. Also, we are asking for Lord God to guide us in the path we walk in. Looking to see you soon Fr. John!.

Rexene's boyfriend ~~is~~ is Richard I don't know his last name and I only meet him once. He just travel with he's team to play in Mindoro Occidental. Rexene is 21 years old same age with Ana Sophia Dayrit Macapagal 21. Yes, she was enrolled at Bulacan University in 2024. Ana and Rexene were very closed friend but I don't know Ana as we don't have any interactions. I'm so sorry to disappoint father but I really don't know her/their boss is also my friends and family are trying their best to find them. They not stay in HK but they been traveling here in HK couples of time. This is all I know, its not much but I hope it help father.

Father John, I want to seek a help from you about my sentencing. ~~My~~ My case have been already moved to District Court and that my next court is on June ²⁵ ~~26~~, 2026. After this ~~my~~ probably my next court hearing will be my date of sentence maybe on September or October. And I want your help father, what should I do to make my sentence less. Any help or advice will be appreciated. This month's hearing I'm pleading guilty. Thank you so much father for the help and hopes you gave us, it's really means a lot to all of ^{us} here.
