I received your letter in regards with our case. i'm able to confirm that the picture that you sent me is my friend "anna" she's currently enrolled in "Trinity University of asia" located in E. Rodriguez Quezon City and before i got arrested she was living in "Victoria Sports Condominium" In "Kamuning Quezon City" I forgot which floor but she's in tower 01 as far as I remember, anna is the master mind of all of this she used to go back and forth here in hongkong and she's the one who recruit "Rexene Cortez" in this, she have a hongkong boyfriend that's friends with the pakistani boss. anna is 22 years old and Rexene is 23 years old, and the black american boyfriend of Rexene is playing basketball league often times they go to Mindoro to play. I know coz rexene told me about this before.

In second week of October 2025, Rexene go to thailand -> HK to do this business, and she passed the airport coz we are able to still meet in manila after she go here in HK, from there they convinced me that it's really just Rolex and some Jewellery, coz she was able to make it to Manila, during the entire process anna is the one booking all my flights and accommodation, meanwhile as per what I've heard from them "The boss" (which happen to be a pakistani) was sending money directly to Rexene thru Western Union, I even have a proof on my phone fr. It's a video of Rexene booking my flight on her phone, and she was also holding the money she will use to book my hotel.. I also have all the screenshots of our conversation on my phone fr..

I think Rexene now was still living with her Boyfriend In Grace Residences.. I'm not just sure which tower but the BF's name was "Richard" I forgot the last Name.. As my friends told me, Anna now was living her life to the fullest.. have a new Condo Unit, and a new Car.. and her and Rexene were still friends, and still victimizing people in the philippines. I think you already know about "FRANCINE MIRANDA" fr.. the latest victim of anna & Rexene. Was just catch last february w/ 2kg of cannabis.. As far as I know fr. there's an on going case for them in the philippines.. but I don't even know if we can trust this

happened. I ~~even~~ even told them every bit of information that I have. I was able to get an interview together with the NBI agent that handdler our case.. they told me that they're interested to conduct the interview with me coz I can identify both anna & Revene Next week I will try to Request for consolate call and ask for any updates Fr..

Just let me know Fr What else information that you need from me, I will also write for you if Icare I got some updates by Next week, Thank you so much fr for all your help I hope that this information help us to seek for justice.. because she 'will never stop fr. specially Now her mom was sick I think have breast cancer and going back & fort to hospital.. One needs Money for her Mom's Medication (ANNA's mom)

That's all for me now Fr. May God Bless you and your kind heart fr. Thank you so much for all the help ☺
