
Letter to Informant / Witness for Case with Insufficient Evidence

its contents are true to the best of my knowledge

from my own observations. My complaint is not
the sentence itself but rather that the decision not
to prosecute the man Phaxat Lathief also known
as Lucky or Philip, Lucky was the man who had
recruited me into drug trafficking and for whom
I was working at the time of my arrest, arrest,

I described how I had been introduced to Lucky
and the mechanics of my part in his operation
which involved daily substantial amounts of both
cocaine and cash. I accept that, I did not provide
detailed names of people or places but this is
because while I could recognise these places,
I did not know their names in English or Chinese
although I could have taken police to them to
point out the specific locations. Nevertheless it
surely contains sufficient material, at least once
Lucky is identified, for him to be prosecuted for

Conspiracy with me and others to Traffickme in a substantial quantity of dangerous drugs over a period of month, further I told you. I was shown my mobile phone number - 67515475, records and phone and was able to identify 3 Numbers shown

① as Bhai - 9793.3731, ② Bhai - 61635581, and ③ LAC - 6429.5046 as being Lucky's numbers and as numbers on which I had successfully contacted him, Pharaat lathief at least as it sounded to me, I provided the number of Lucky, recognisance RBE - 35839/08 and the reason why I had delayed

in supplying it to the police This was surely enough to allow him to be both identified and arrested on the next occasion he report to the Immigration Department.

On day officers from NB Team 3D again came to visit me They showed me 13 photos numbers 1 to 13 and asked me if I could identify lucky amongst them, I did so I put number 10 on a piece of paper but this was not recorded in any NPs, The officers told me that I should wait 6 months for them to investigate and that I should not write any more letters to either the chief executive or other Hong Kong government, I agreed to do so, There had however been no reply from the police and in particular I have not been asked to attend any Identity Parade.

I regard this as most unsatisfactory and unfair of the view that circumstances of my own arrest clearly indicate that Lucky who instructed me to the drug I was carrying that night an African man called Nonso who gave me the bag very shortly

before my arrest but was not arrested himself were both involved with Narcotics Bureau officers who arrested me and yet remain at liberty and continue trafficking. I have met many people after who have similarly been arrested delivering drugs for Lucky at the time of their arrests

I can provide their names, I believe that Lucky and his people are being protected by the Narcotics Bureau and allowed to continue their very profitable trafficking business in exchange for the lives of those they have deliberately set up whilst those unfortunates like me who offer assistance to try and mitigate their consequent punishment are ignored and thereby deprived of the chance to reduce their own sentence as well as stop the exploitation of others and the resultant damage to society. Last month police came visit to me. They say only if many people write to police they can arrested to Lucky and they came to ID parade they are only laid talk, I say to police your department protection given to Lucky how come you're arrested to Lucky they are say we're coming soon - that at
