Re: A complaint against the Narcotics Bureau
of the Hong Kong Police Force
Fharrukh Latif

Your letter addressed to the Hong Kong Bar Association has been forwarded to me in my capacity as the co-ordinator of the Bar Free Legal Service Scheme.

It would appear that you are disappointed that the information that you gave to the Narcotics Bureau regarding the identity etc. of a person by the name of Fharrukh Latif did not yield any positive result in that Latif did not seem to have been arrested/prosecuted. And because of this lack of positive result, you have been deprived of an opportunity to seek reduction in the sentence that was imposed upon you in HCCC 175/2015.

You are concerned that the Hong Kong Narcotics Bureau (at least the team who dealt with you) may be corrupt and they have been protecting the masterminds of drug trafficking.

For your information, if you have any complaints against any police officers (Narcotics Bureau officers are police officers), you should make a formal complaint to CAPO, namely, Complaints Against Police Officers. CAPO is the watchdog unit that investigates complaints lodged against police officers. The address of CAPO is as follows: -


Letter to Informant / Witness for Case with Insufficient Evidence
